ADDITIONAL TERMS AND CONDITION

1. The Plan and Specifications of the work may be seen and all other particulars may be ascertained from the office of the undersigned during the office hours on the working days as specified in the NIT.
2. The security to be taken with a deduction of 8% (eight percent) from every interim payment made on account of the work done up to completion of the work or a deposit.
3. No labourers under 14(fourteen) years of age shall be employed on the work and all labourers employed should have to be paid at rates not less than those generally paid for similar works in the neighborhood.
4. The Chairman does not bind himself to accept or to recommend for acceptance of the lowest or any tender. The work may not be allotted to any tenderer without assigning any reasons.
5. The contractor should quote in their tender, the current registration no & class to which they belong supported with attested copy of current registration.
6. The tender must deposit earnest money @ 2% of the tender value in the respective group in the form of call deposit/fixed deposit etc. duly pledge in favour of The Chairman, Sribhumi Municipal Board, Sribhumi.
7. Successful bidder after receipt of the work order shall start the work immediately. If he/she fails to start the work on time then his/her security money will be forfeited and work will be allotted to other bidders as per the procedure.
8. No enhancement of rates will be entertained under any circumstances.
9. The tender should be accompanied by attested copies of valid labour licence, GST & Pan card etc. for the current financial year.
10. Every page and all corrections in the tender must be initiated by the tenderer before submission of the same. Tenderers having the corrections and not initiated by the tenderers will be rejected.
11. *The tender must be affixed court fee stamp of Rs. 8.25 (Rupees eight & paisa twenty five) only, any tender received without the required court fee stamp shall not be considered.*
12. The tenderer(s) should quote their rate both in figure and in words clearly.
13. If the bid has been submitted by the firm then it should from the appropriate authority or an authority with the power of attorney.
14. It is to be noted that this department's liability is to be contractor only and nobody else. As such, it will be discretion of the Executive Officer to accept or to refuse a Power of Attorney during execution in favour of any other persons or body.
15. If the successful contractor fails to deposit the S.D. money in time 2% (two percent) earnest money will be forfeited & recovered from item with due notice from the fixed deposit with the Govt.
16. All works will be executed as per the PWD Assam general specifications.
17. The expenditure is debitable under the Head of Account 15th Finance Commission (Urban) Tied Fund from Sribhumi Municipal Board
18. The sanctioned TS amount should not be exceeded under any circumstances.
19. The procurement of materials such as UPVC pipes class-III (6.00 Kg. per cm²) and other materials are to be made as per on the basis of rates adopted under JJM, Assam and should be procured from empanelled company and quality test certificate of the pipe must be submitted to the AEE (PHE) Sribhumi Sub-Division before a connection with PHE existing pipe line.
20. Progress reports of works should be submitted time to time to the undersigned.

21. All cost of carriage of materials and tools etc. any other expenditure should be included in quoting the rates.
22. Tenderer should mention their present and permanent address in tender paper clearly.
23. All T & P materials should have the contractors for the execution of works.
24. No free permit for extraction of river single, metal, boulders, sand etc. from quarry owned by the State of Assam as well as District Council of Autonomous District will be issued to the contractor.
25. Contractors should pay the forest royalty on those materials direct to the Forest Department fixed by the Forest Department from time to time and obtains receipt there from, any tools charges to be levied by the forest for use of quarry roads, i.e. the said extra has to be borne by the contractors. These should include all those cost.
26. The contractor must have their machineries required for the execution of works.
27. The contractor at his own cost shall arrange Chowkidar, Signal Lamp, Cautionary Signboard etc. for regulation of traffic during execution.
28. The Schedule Tribe/Schedule Caste/OBC contractors and unemployed Diploma/ Graduate Engineers will deposit only 50% of the specified amount of the security deposit as admissible.
29. Tenderers should quote their attested copies of valid labour license number obtained from the labour office & registration office for the contractor for labour Registration and Abolition Act 1970 and N.C. Hills failing which the tender will not be considered.
30. Coarse aggregate will be measured at site before laying by the department as necessary.
31. Stock materials such as cement, steel, bitumen etc. to be procured by the contractor at their own cost and relevant test reports for these materials should be submitted to the department.
32. *The contractor will have to pay requisite GST on the overall bill amount of the work done as per Government notifications prevailing on the state.*
33. *Once the work is allotted, the contractor has to continue the work till completion of the work without any halt in the executions.*
34. The contractor will not be allowed to stop the work at the plea that fund has not been released. The estimate will not be revised for price escalation for increase in market rate of materials etc.
35. The execution agency is not bound to make payment of Running Bill.
36. The contractor cannot discontinue or delay the work on the ground of non-payment of Running Bill.
