Sealed quotations, affixing Court Fee Stamp of ₹8.25 (Rupees Eight and Paise Twenty-Five only), are hereby invited from registered and experienced firms/dealers/suppliers for supply of the refreshment items at **Annexure-A** in connection with the forthcoming Census Operations-2027.

Sealed quotations shall be submitted in the Quotation Box kept near the Office chamber of the Addl. District Commissioner & District Census Officer, Sribhumi. Quotations must be received up to **3:00 PM on 02-06-2026** and will be opened on the same day at **5:00 PM** in the chamber of the Addl. District Commissioner & District Census Officer, Sribhumi.

Intending quotationers or their authorised representatives may remain present at the time of opening of the quotations.

The undersigned reserves the right to accept or reject any or all quotations without assigning any reason whatsoever.

TERMS & CONDITIONS OF SUPPLY OF REFRESHMENT IN FORTHCOMING CENSUS OPERATIONS 2027:-

- Rates shall be quoted item-wise, both in figures and in words. In case of discrepancy, the rate quoted in words shall prevail.
- The maximum admissible rates for refreshment items under this tender shall not exceed the rates approved during the General Election to Assam Legislative Assembly, 2026.
- The tenderer shall clearly mention valid Registration Number, GSTIN, PAN and Bank Account details with IFSC Code in the quotation. Applicable statutory deductions, if any, shall be made at source as per Government rules.
- The sealed cover containing the quotation shall be superscribed as: "Quotation for Supply of Refreshment Items with Catering Service – Census Operation-2027."
- Tea and coffee shall be served in good quality paper cups. Breakfast, refreshments, lunch and dinner shall be supplied in proper packets / silver foil containers / disposable plates or bowls, along with napkins, spoons and drinking water, as applicable.
- The supplier shall make own arrangements for cooking, transportation and serving of food through appointed staff and shall have sufficient manpower (minimum 20 persons) with experience in catering services. On demand, the supplier shall be capable of supplying 200–500 packed meals per day with proper packaging.
- All food items shall be freshly prepared, hygienic and wholesome. Quality and quantity specified in the tender shall be strictly maintained.
- Security Deposit:
A Refundable Security Deposit of ₹20,000/- (Rupees Twenty Thousand only) and a Non-Refundable Processing Fee of ₹2,000/- (Rupees Two Thousand only) shall be deposited along with the quotation in the form of NSC / TDR / Demand Draft, drawn in favour of the Addl. District Commissioner & District Census Officer, Sribhumi.
- In case food supplied is found to be of inferior quality, unhygienic, delayed or short in quantity, the Security Deposit shall be liable to forfeiture wholly or partly, and the work order may be cancelled, with further legal action if required.
- Any food item found to be unfit for consumption shall be rejected and replaced immediately by the supplier at no extra cost, failing which penalty shall be imposed.
- Cleaning of Premises: The supplier shall ensure proper cleaning of the premises after supply and consumption of food, including removal and safe disposal of food waste, disposable plates, cups and packaging materials.
- In case of failure to clean the premises satisfactorily, the Department may arrange cleaning at the risk and cost of the supplier, and the expenditure incurred shall be recovered from the Security Deposit.
- The caterer shall not discontinue services under any circumstances until the Census activities are over.
- Payment shall be made only for actual quantity supplied at approved rates, subject to certification by the competent authority.

- The quoted rates shall be inclusive of all incidental charges except GST.
- This tender is invited solely for fixation/approval of rates for supply of refreshment items in connection with Census Operation-2027. Participation in the tender process shall not confer any right upon any bidder to claim issuance of work order, supply order, or assured engagement by the Department. The Department reserves the right to place orders as and when required, wholly or partially, without assigning any reason thereof.
- The undersigned reserves the right to accept or reject any or all quotations, wholly or partially, without assigning any reason whatsoever.
