They are directed to lift the allotted quantity of Masur Dal, Sugar and Salt from the designated AWCS godown as approved by Govt. & issue the quantity among tagged Fair Price Shop Dealer/Retailers using ePOS Device @ 1.00 Kg per card both AAY & PHH at subsidized rate within timelines fixed by Govt. and also to ensure properly measure the quantity & check the quality of commodities while lifting from ASWC godowns, and similarly the FPS should properly check the quantity and quality of packets received from their respective GPSS/WCCS/LAMPS and update the received quantity same in ePOS. They should ensure that no damaged packets are handed to the NFSA beneficiaries
