Allotment of atta 2850.00 Qntl. of Roller Flour Mill under Tide Over wheat received from the Commissioner, Food, Civil Supplies, Consumer Affairs & LM, Assam against monthly allocation for the month of September/2024 vide Director of FCS & CA Assam's allotment order E File Memo No. 505108/112 dated 12/09/2024 and also 931.00 Qntl. alongwith unlifted 142.12 Qntl. of atta on account of Modern Chakki Mill received against monthly quota of wheat for the month of September/2024. Thus, the total 3923.12 qntls of atta has been sub-allocated among the willing nominees (GPSS) as per online RCMS Data (RC) of this District for onward distribution to the PHH Ration Cards holders under NFSA @ 2.6295 KG per card.

The allotted atta shown against each nominee below is to be lifted from the concerned R.F. Mill & Modern Chakki Mill as mentioned against each within 05/10/2024 and distribute among the PHH holders under NFSA at Govt. fixed price subject to maintaining of proper accounts under strict supervision of the concerned Area Officers of Food, Public Distribution & Consumer Affairs Deptt.

All concerned Mills will submit the lifting position of atta allottee-wise immediately after expiry of the last date of lifting and also submit monthly lifting and distribution report through the concerned Area Officers of Food, Public Distribution & Consumer Affairs, Karimganj. (Qnty. in Qntl.)

- 11) Concerned RF Mill/ Modern Chakki Mills are requested to deliver the same among allottees (GPSS) concerned within the validity period on payment of price at Govt. fixed rate & submit report through their concerned AOs in due course for onwards submission to Govt. without fail. Further, they are directed to kept reserved stock of Wheat Bran to meet any emergency like flood etc. during the monsoon period as per Govt. direction.
- 12) All other allottees (GPSS) concerned. They are directed to lift the allotted quota of Atta from the RF/MC Mills and issue the same to their FPS/agents for distribution to PHH Ration Card holders accordingly and submit utilization certificate henceforth.
