Further, they will keep strict vigilance to avoid diversion, leakage and malpractices of allotted rice and ensure distribution of rice to the AAY beneficiaries @ 35.00 KG per Ration Card & @ 5.00 Kg per member of PHH Ration Card under NFSA at free of cost and immediate penal action should be taken against FP Shop dealers/agents if any diversion is found or who charges value of rice from beneficiaries as per NFSA Act and submit compliance report to the undersigned without fail.
- 13) All Transporters under NFSA/2013 of Sribhumi District. They are directed to lift the allotted foodgrains(rice) PMGKAY under NFSA from concerned FCI Depot's (Tier-I) within the validity period on 31/03/2025 repeat 31/03/2025 positively and also directed arrange to make door step delivery up to FPS level (Tier - II) within 31/03/2025 for distribution of the same among beneficiaries (Ration Card Holders) as per RCMS Data of FPS and beneficiaries list as per scale fixed both AAY & PHH Ration Card holders(NFSA) by Govt. without fail.
- 14) All GPSS/WCCS Secretaries, Sribhumi. They are directed to arrange to receive the allotted quantity of PMGKAY rice under NFSA from Transporters under NFSA within the 31/03/2025 and simultaneously to arrange for delivery among the FPS Dealers after adjustment/deduction closing balance of Rice for the month of March/2025 in consultation with concerned Area Officers within 31/03/2025 at free of cost and fixed scale (AAY & PHH) by Govt. without fail.
