**MINUTES OF THE DISTRICT DEVELOPMENT COMMITTEE (DDC) MEETING
HELD ON 6th JUNE, 2023 AT 11:30 A.M IN THE CONFERENCE HALL OF THE
DEPUTY COMMISSIONER'S OFFICE, KARIMGANJ**

Members Present – As per Annexure 'A'

The meeting was chaired by Sri Mridul Yadav, IAS, Deputy Commissioner, Karimganj. At the outset the Chairman, welcomed all the members present in the meeting. Thereafter a small introductory session was held with the District Head of the departments and newly joined District Development Commissioner and Additional Deputy Commissioners.

Thereafter, the minutes of the D.C's conference held at Tinsukia, was presented before the house and detailed discussion was held on each and every points of the minutes. The Deputy Commissioner extended guidance, highlighting some points of the department, how to take action on the same. The Deputy Commissioner instructed all the District HODs to take action on their respective points and submit report within 10 days.

Action: All the District HoDs, Kxj.

Then the review was started department wise which are recorded as follows:-

1. **PHE** : It was reflected from the report submitted by the department that the status of running water facility in Schools and Aganwadi Centers is 78% and 67% respectively. Out of target 1882 nos & 1301 nos, 411 nos. of schools and 427 nos. of AWCs are yet to be covered.

The Executive Engineer was instructed to take steps so that the same may be completed early.

Action: The Executive Engineer, PHE

2. **PWD (Building)**: The Executive Engineer appraised the house about the different on-going schemes of the department. Regarding electrification work of swimming pool and Deen Dayal College, the Executive Engineer apprised that the same is yet to be done. He was instructed to take steps to complete the work within 15 days.

Further, the report submitted by the department reflected that the progress of the following schemes under different programmes are not satisfactory viz. Construction of 1000 capacity Auditorium at R.K. Nagar, Construction of 09 Nos Model Women College under education department, Establishment of Pandit Deen Dayal Upadhyay Adarsha Mahavidyalaya at Ratabari, Construction of Government Modern College at Bazaricherra at Patherkandi, Construction of RCC Delivery Room with Neonatal Room at Kaliganj Hospital etc.

The Executive Engineer was instructed to take personal initiative for completion of the schemes at the earliest.

Action: The Executive Engineer, PWD (Building)

3. PWRD (North Kxj, South Kxj and Badarpur): On review of the progress of different schemes, it was found that the progress of the 4 nos. schemes out of 7 nos under PMSGY III is slow i.e. in between 50% - 62%. The Executive Engineer was instructed to expedite the work so that the same may be completed early.

Action: The Executive Engineer, PWRD (North Kxj, South Kxj and Badarpur)

4. AGRICULTURE: - The progress of different activities of the department was reviewed in the meeting. The DAO was instructed to take necessary steps on the following points-

1. Establishment of procurement center.
2. Select more product under ODOP as flexibility has been given on the same.
3. Organic farming / Millet farming.

Action: The DAO, Agriculture

5. WATER RESOURCES: The Executive Engineer appraised that necessary measures against vulnerable points has already been taken and constant watch are on by regular monitoring.

Regarding rejuvenation of Natikhal canal he apprised that steps are yet to be taken. The Executive Engineer was instructed to take necessary step for the same immediately.

Action: The Executive Engineer, WR

6. IRRIGATION (Ratabari/ Patherkandi Division): The report presented by the department reflected that the following 2 nos. of schemes "Piplapunji cherra FIS (AIBP) and Maguracherra FIS (AIBP) have not been completed within the stipulated time (March 2023). The progress of which is 85% and 97% respectively.

In this regard, the Executive Engineer reported that Piplapunji cheraa FIS will be completed by Nov' 23 and at Maguracherra, one brick canal yet to be done. He was instructed to complete the same early as minor portion of work is left to be completed, so there is no justification to take much time.

Action: Executive Engineer, Irrigation (Rataberi/Patherkandi division)

7. TRANSPORT : The DTO (I/c) reported that the revenue collection for the month of May is Rs.1.18 Cr and cumulative Rs.2.42 Cr. Out of targeted Rs.20.30 Cr. for the FY 2023-24.

Further he appraised the house that the road accidents are increasing in the district in recent times. He pointed out that these are for non compliance of safety measures while driving/ riding & also transportation of laboures in goods carrying vehicles especially in the tea garden areas. He requested all the District HOD's to ensure road safety measures while driving / riding by Govt. officials in their respective department. In this connection the Deputy Commissioner instructed all to take action accordingly and also instructed the Labour officer to spread awareness in the tea garden areas through Labour Inspector regularly to avoid any untoward incidents. The Deputy Commissioner opined that, the increase in number of accidents is a bad sign of the district & urges all to spread awareness among public/visitors in their offices as well as staff.

Action: 1. All HoD's, Kxj

2. The Labour Officer, Kxj

8. **DICC:** On review of progress of work under PMEGP and PMFPE, the G.M apprised that ,the bank support on PMEGP was satisfactory but PMFMPE is poor.

He was instructed to take up the matter with the LDM & LDM was requested to look into the matter.

Action: 1.G.M, D.I.C.C

2. L.D.M., Kxj

9. **FISHERIES:** The progress of different activities of the department was reviewed. It was reflected from the report that, the progress of some activities regarding PMMSY for the year 2021 -22 and 2022-23 are not satisfactory. He was instructed to complete the same within the stipulated time.

Furthermore, the DFDO appraised that regarding KCC loan for the year 2020-21 and 2022-23, the support from the bank is not satisfactory. The DFDO was instructed to take up the matter with LDM.

Action: 1.The DFDO, Fisheries

2. The L.D.M., Kxj

10. **EXCISE:** The Superintendent of Excise apprised that the revenue collection is Rs. 2.24 Cr for the month of May and cumulative collection is Rs. 4.91 Cr. out of targeted Rs. 34.26 Cr. for the FY 2023-24. Further he apprised that steps such as raids & seizing of illicit liquor are carried out by the department regularly.

Then the meeting ended with vote of thanks from the chair.
