

Subject	MINUTES OF THE DISTRICT DEVELOPMENT COMMITTEE MEETING, SRIBHUMI

The meeting was chaired by District Development Commissioner, Sribhumi.

At the outset the District Development Commissioner, Sribhumi welcomed all the members and officials present in the meeting.

The District Development Commissioner explained about the various indicators of E-Samiksha and requested all the HODs to submit the report on priority basis concerning their department.

Thereafter, the District Development Commissioner reviewed the progress of works of various departments and decisions and directions in the meeting was recorded department wise as follows:

The DDC raised concern over no progress of works in comparison to the last DDC meeting under the scheme. The department was directed to expedite the progress of all remaining works.</p>	DSWO

18	Water	The activities of the deptt. was reviewed in the meeting. The E.E appraised that schemes under different programmes are going on.	E.E.

	Resources	The DDC directed the E.E to complete the ongoing schemes within target date of completion.	
19	Soil Conservation	The DO reported that 1 no. of scheme sanctioned under RIDF is yet to be started.	DO
20	Municipal Boards	The Executive Officers of all MBs appraised that activities of the deptt. such as collection of P.Tax, Door to door waste collection etc. are going on.
