In pursuance of W.T. Message No. DSE. 74/2023/149 dated 12/10/2023, sub-allotment of S.K. Oil for the month of October, November and December/2023 is hereby made among S.K. Oil Depot (IOC) of Karimganj District to lift the allotted of S.K. Oil from IOC Depot at Silchar within 23rd day of the month for issue of the allotted quantities of S.K. Oil to the Agents/F. P. Shop Dealers of Karimganj District for onward distribution to the NFSA Card holders @ 0.460 Ltrs. per Card under NFSA for the month of October, November & December/2023 per month separately both urban & rural area by respective PDS Agents of concerned GPSS/WCS of the District at Govt. fixed rate as well as for distribution through S. K. Oil Hawkers to NFSA Card holder both in urban & rural area as usual within the month.

The allotment is made against the S.K. Oil Depot taking into account of the closing stock of previous month keeping harmony with tank lorry.

The allotted quantity of S. K. Oil should be distributed as per requirement under supervision of concerned Area Officers of Food, Public Distribution & Consumer Affairs Department for fair distribution of the allotted S.K. Oil. The S. K. Oil Agents concerned should submit lifting position in due course along with closing stock at the end of the month for taking further action with due countersignature of the concerned Area Officer. Necessary adjustment of allotted S. K. Oil of hawkers may also be made by the concerned Area Officer in Depot-wise & to submit report in due course.

There should not be any reserve stock in the S. K. Oil Depot & no S. K. Oil should be delivered on Special Permit as per Govt. instruction.
