O R D E R

Whereas, it is reported that there is a fear of movement of extremist elements with a view to create law and order problem in the district and,

Whereas, there is an apprehension of unauthorized movement of commodities / cattle from this district through the areas surrounding the district borders, which if allowed to take place is likely to cause disturbance and in my opinion immediate prevention and speedy remedy to stop these illegal activities are desirable.

Now, therefore, in exercise of powers conferred upon me U/S 144 Cr.P.C., I, MRIDUL YADAV, IAS, District Magistrate, Karimganj do hereby direct as follows:-

1. No person shall move between Sunsets to Sunrise within a belt of 500 (Five hundred) Meters of Indo-Bangladesh border of Karimganj district.

2. No person shall move near the river Kushiara and near Border fencing in the district of Karimganj between the hours of Sunset to Sunrise.


3. No person shall ply boat in the river Kushiara for the purpose of fishing. Permission for fishing may only be given to local people by Circle Officer, Karimganj for their personal consumption after obtaining due permission from the lessee, as per the terms and conditions of the lease. Copy of such permission should be endorsed to the District Magistrate, Karimganj and Commandant, 16th Bn. B.S.F., Patharkandi, Karimganj.

4. No person shall carry, by any Vehicle, Thela, Rickshaw or by any other means any quantity of Sugar, Rice, Wheat, Edible Oil, S.K. Oil and Salt etc. between the hours Sunset to Sunrise within 5 Kms belt inside the district boundary of Karimganj along Indo-Bangladesh border provided that permit may be issued in this regard by the Circle Officers, Karimganj/ Badarpur/ Nilambazar/ Patharkandi for their respective jurisdiction, who will only permit relaxation if any, for specific purpose, time and place after verification from the local Supply Officials with a copy to the District Magistrate, Karimganj and the respective Commandants of BSF.

This order shall not apply to the State and Central Government Employees on duty in the border areas.

This order is issued ex-parte in the interest of public order and shall come into force with immediate effect.
This order shall remain in force until further order.
