

**MINUTES OF THE DISTRICT DEVELOPMENT COMMITTEE (DDC) MEETING HELD ON 17<sup>th</sup> August' 2022 AT 11.30 A.M IN THE CONFERENCE HALL OF DEPUTY COMMISSIONER, KARIMGANJ.**

Members present - As per Annexure -"A"

The meeting was chaired by Shri Mridul Yadav, IAS, Deputy Commissioner, Karimganj. At the very outset he welcomed all the members present in the meeting.

Thereafter, minutes of the review meeting by Hon'ble Chief Minister, Assam held on 01/08/2022 was thoroughly discussed in the meeting point wise and the concerned department apprised about the activities so far made by them on the points. The Deputy Commissioner, Kxj requested all the heads of the department concerned to take further initiative to accomplish the task slated as point under different programme in the said minutes. Besides this some decisions were taken for proper implementation of few points which are as follows:-

**1. Ayushman Bharat :-**

Regarding 'Apke Dwar Ayushman' the department should fix timeline and make wide publicity of the same. It was also decided to convene a meeting shortly on the matter.

**Action: Jt. Director, Health Services, Kxj**

**2. Mukhya Mantri Souro Shakti Prokolpo :-**

(a) Regarding encouragement of Floating model it was pointed out in the meeting that 1 (one) project has already been done at Sonbeel, the department was requested to take necessary steps for another project where there is feasibility / probability of the same.

(b) Regarding a solar power generation It was decided to convene a special meeting for discussion on implementation of the project.

**Action -AGM, APDCL, Kxj**

**3. Crop diversification :-**

Discussion was held on the point, the Agriculture officer present in the meeting apprised that the farmer of the district are not interested on crop diversification. The Deputy Commissioner requested him to take initiative to aware the farmers about the profit of crop diversification. He was further requested to take up a plan on pineapple processing unit as there is possibility for a successful project.

**Action- DAO, Agriculture, Kxj**

**4. Celebration of village foundation day:-**

The CEO, Zilla Parishad was requested to take early step for the same.

**Action—CEO, Zilla Parishad, Kxj**

**5. Adopt an Anganwadi by local colleges, Universities, renowned families etc. :-**

The DSWO was instructed to take steps on the matter early. Further the Deputy Commissioner requested all the Heads of the Departments to adopt an AWC beside their offices or area which is convenient to them.

**Action: 1.DSWO,Kxj**

**2.All District Heads of Karimganj**

**6. Sansad Khel Khud Spardha :-**

The District Sports Officer was instructed to take early action in the matter. In this connection it was pointed out in the meeting that some amount for sports activities in the schools (LP, ME, High & H.S.S) are provided annually by the Govt. The Deputy Commissioner, Kxj instructed to the Sports Officer to enlist specific items for the schools which are to be procured with this amount. She was further instructed to convene a meeting on sports activities early.

**Action: I.S, KXJ and District Sports Officer, Kxj**

**7. C.M Dashboard :-**

A discussion was held on data entry in CM dashboard. It was apprised to the departments concerned that the target provided by the department are not matched with the figure giving in the Govt. format which arises confusion. The department was instructed to take up the matter with their apex offices. It was also apprised them that issue / problem faced on the matter has already been taken up with Govt. but response yet to be received.

**Action: All Concerned Heads of department, Kxj**

**Discussion on inter-departmental issue**

**1. PWRD :-**

The E.E, PWRD raised the issue of road damage by the PHE works, which was also supported by E.E, NH, Kxj. The E.E, P.H.E apprised that some part has already been repaired and remaining will be done shortly. It was instructed to both departments to jointly verify the site before making final payment to the contractors by the P.H.E department.

Further, the E.E, PWRD and E.E,N.H Kxj was instructed to submit the list of road with pin point location of the damage caused by P.H.E works to the Deputy Commissioner, Kxj early.

**Action : E.E, PHE, E.EPWRD & E.E N.H, Kxj**

**2. Transport :**

The D.T.O, Kxj apprised that he is facing problem for registration of e-rickshaw as the APDCL authority instructed to collect NOC from APDCL authority regarding power consumption by the e-rickshaw owner. The e- rickshaw owners are reluctant to collect the same as they have to pay high amount of power charge for the same. In this connection D.T.O was instructed to write in black and white about the matter to Deputy Commissioner, Kxj.

**Action : D.T.O,Kxj**

**3. Zilla Parishad:**

The C.E.O Zilla Parishad apprised that the APDCL authority are sending power consumption bill against water supply scheme by the name of CEO Office which makes



difficulties to ascertain the bill against the water supply schemes which should be by the name of Pani Samiti of the concerned schemes. In this connection, the APDCL authority was instructed to send the bill specifying the name of Pani Samiti concerned and the E.E, PHE, Kxj was also requested to provide the list of Pani Samiti / User group to APDCL authority early.

**Action : E.E, PHE, & A.G.M, APDCL, Kxj**

**4. Health Services:**

The Jt. Director Health Services apprised that for smooth functioning of Civil Hospital a dedicated feeder line is necessary for the Hospital. The matter was discussed and pointed out that a good amount will be required for the same but there is no source of fund. The Jt. Director Health Services was suggested to take up the matter with his higher authority.

**Action: Jt. Director Health Services**

**Review on the achievement / activities of different departments**

**1. Health Services:**

- a. The activities of the health department was reviewed. The Jt director was requested to submit in detail the activities taken on the programme ' Sas Bahu Sammelon' in the month of August to the Deputy Commissioner, Kxj.
- b. Regarding the programme 'Naya Pahel', it was decided that to make awareness of the programme and the District Media Expert to be engaged for this purpose.
- c. A discussion was held on Home delivery and Child marriage etc. it was decided to convene a meeting with Health, Education and Social welfare department early.
- d. The Jt. Director Health Services raised the issue of use of Tobacco/ Tobacco product as well as selling of the same in the district which are dangerous to health. He pointed out that the product are being sold openly in the district even beside the School and colleges. It was decide that a drive headed by Magistrate to be taken urgently. The ADC, (Magistracy) was requested to take action accordingly.

**Action: 1.ADC, Health/ Education/ Social welfare**

**2.Jt. Health Director, ADC, Magistracy**

**2. APDCL :**

- a. The AGM, APDCL reported in the meeting that the land for establishment of Sub Station selected at Sutarkandi is not feasible. He requested to provide a suitable land for the same. The ADC, revenue was requested to take necessary steps to provide suitable land for the same.

- b. A discussion was held on death caused by electrocution in the district. The AGM, apprised that till now 3 cases are there in the district and proposal for financial grant to the deceased family has already been submitted to higher authority. The AGM was instructed to pursue the matter with apex office for the early sanction of the same.

**Action—1. ADC (Rev), Kxj  
2. AGM, APDCL**

**3. DI & CC :**

It was reflected from the report that total no of beneficiary sponsored under PMEGP to banks has not been received benefit from the bank till now. The LDM was requested again to take steps on the matter seriously so that all sponsored beneficiary may be benefited early.

**Action—LDM, Kxj**

**4. PWRD :**

The EE, PWRD of both division apprised that moisture of the road has already been cleared and the roads are fit to work. The works of the ongoing schemes will be resumed shortly. The E.Es, were instructed to start the work and complete the same early.

**Action—E.E, PWRD (Both div.)**

**5. PHE:**

1. Regarding completion of water supply scheme of Karimganj Jail, the E.E PHE reported that no fund has been released from the Govt. so the contractor has not received any payment and he is not interested to progress the work further. The ADC, (Jail) was requested to take up the matter with the I.G prison, Assam, early.

**Action—ADC (Jail), Kxj**

2. Regarding construction of Community Latrine in each G.P under Swaccha Bharat Abhijan. The E.E reported that the pin point location of the same is yet to be finalized. The CEO, Zila Parishad and E.E, PHE were requested to finalize the same early and to start execution of the same.

**Action—1. CEO, Zila Parishad  
2. E.E, PHE**

**6. PWD(Bldg.) :**

It was reflected from the progress report of the department that no satisfactory progress has been made against the ongoing scheme. The EE, PWD (Bldg.) was instructed to take steps to complete the all schemes immediately.

**Action—EE, PWD(Bldg)**

7. Irrigation---

The progress of schemes viz. 'Installation of solar and electric tube well' are not satisfactory against both the division. The E.Es were instructed to take immediate steps to complete the same early. They were also instructed to convene weekly meeting to monitor as well as expedite the work.

**Action:-- E.E , Irrigation (Both div.)**

At the end, a discussion was held point wise on the action point of the minutes of the D.C's conference held at Tejpur. All the heads of the departments were requested to submit action taken report on the points related to their departments to the Deputy Commissioner early.

**Action: All the Heads of the Department**

Then the meeting ended with vote of thanks from the Chair.


