MINUTES OF THE DISTRICT DEVELOPMENT COMMITTEE (DDC) MEETING HELD ON 14th OCTOBER'2022 AT 11.30 A.M IN THE CONFERENCE HALL OF DEPUTY COMMISSIONER, KARIMGANJ.

Members present - As per Annexure - "A"

The meeting was chaired by Sri Mridul Yadav, IAS, Deputy Commissioner, Karimganj. At the outset, the District Development Commissioner welcomed all the members present in the meeting and initiated the discussion.

At the beginning, the Deputy Commissioner appraised the house that the DDC meeting is the important forum to review the activities / programme implemented by the various department as well as to solve the inter-departmental issues.

Thereafter a review was taken on the poor achievement of the departments i.e. Health, Housing & Urban, Social Welfare reflected on the CM Dashboard. A threadbare discussion was held on the matter. The department pointed out that this was due to mismatch of target. The departments were instructed to bring it to notice of the apex authorities with intimation to the Deputy Commissioner, if any anomalies on target or any other issues are there.

As regard observance of Lachit Diwas, the Deputy Commissioner instructed all the departments to submit a write up (300-400 words) to Cultural Affairs Department which to be observed on Nov' 2022.

Action:- All Heads of the departments.

Then the issue of some departments were discussed. The decision and direction were recorded as follows-:

Health: -

- As regards non functioning of P.H.C several complains are being received by the District Administration. In this connection, Jt. Director of Health Services was requested to visit the PHC regularly and monitor the functioning of PHC. Besides this, the Addl. Deputy Commissioner (Health) was also instructed to review block wise performance of the PHC in a schedule manner.
- Regarding high maternity / children mortality rate in the district, the Jt. Director of Health Services pointed out that this is due to home delivery and lack of awareness among the people. The Jt. Director of Health Services requested all the department to aware the people gathered in their departmental programme/ function about the same specially in the tea garden area. Further it was decided that the District Social Welfare Officer should take initiative for protection of child marriage and lodge FIR against the defaulter and for awareness the matter may be tagged with Nesha Mukti programme.

Encroachment of Govt office/Land etc.-- The departments were requested to bring it to notice of the District Administration, if any such issues are with the department.

Action:- All Heads of the departments.

APDCL:-

- > The AGM, APDCL was instructed to take necessary steps against the Schools and Anganwadi Centres where low voltage problem arises and submit report.
- ➤ Regarding realization of the electrical bill, the AGM was requested to drive a campaign for the same and take steps against major defaulter if necessary deployment of police personal may be made.
- As regards compensation of death caused by electrocution in the district, the AGM appraised that out of 4 (four) cases compensation has already been provided to 2 (two) families and 2 (two) cases are pending due to lack of documents, which to be submitted by next of kin of the deceased. The AGM was instructed to dispose the same early by taking personal initiative.

Education:-

The Addl. Deputy Commissioner (Education) appraised the house in details about the scheme viz. 'Aarohon' and 'Bidyanjaly' and Adoption of AWC where participation of all department were encouraged. The heads of all department were requested for their participation accordingly.

Action:- 1. All heads of department.

As regard, opening of bank account of students, the Addl. Deputy Commissioner, Education appraised that due to non response from some of the bank branches, the opening of the bank account could not be completed for which the department is facing problem to transfer the different grants to the students. In this regard, the Addl. Deputy Commissioner (Education) was instructed to place the matter in DLCC meeting to be held on 20th Oct, 22.

> In order to improve the academic condition as well as performance of the school, the Addl.

Deputy Commissioner, (Education) requested all the officials of the department to visit schools during their field visit and submit report accordingly.

Model Anganwadi Centre---- A discussion was held on Model Anganwadi entre. The E.E, P.H.E and the AGM, APDCL were instructed to take immediate steps to provide water connection and electric connection in the Model AWC respectively.

PHE: Discussion was held regarding the operation and maintenance of the schemes under JJM in urban area. The Executive Officer of the Urban Local Bodies were instructed to take immediate steps to form user committee and forward the same to the Executive Engineer, P.H.E.

Inter Departmental issue: -

PWRD---The Executive Engineer of both the Division of PWRD in Karimganj district raised the issue of road damaged by pipe laying work by the P.H.E department. The Deputy Commissioner instructed both the Executive Engineer of the division to submit report against each road specifying the pin point location of the damage caused by P.H.E to recover compensation from the contractors.

Review of MPLADS/MLAADS/UF/AAGY/Assam Darshan:--

under fund the against taken was MPLADS/MLAADS/UF/AAGY/Assam Darshan , it was found that the progress of some schemes are not review satisfactory. All the construction committees were requested to complete the work early.

As regards the schemes up to the year 2019-20 under MLAADS and Untied fund, the District Development Commissioner directed the Member Secretary/ Technical Member of the construction committee concerned to complete the work in a war footing manner so that the fund may be utilized by 31/10/2022 otherwise the fund will have to be refunded as per Govt. instruction and scheme to be foreclosed.

Action: All President and Member Secretary of Construction Committee concerned.

Inerest Fund MPLADS/MLAADS/UF/AAGY/Assam Darshan:-

All the Executive Agency of the construction committees were instructed to refund the interest accrued against the fund under MPLADS/MLAADS/UF/AAGY/Assam Darshan immediately.

Action: All President and Member Secretary of Construction Committee concerned

CM Initiative:- A discussion was held in respect of plantation done by the different departments under CM initiative. It was decided that the department concerned should monitor the same and replace the dead plant and submit report.

> It was appraised the all departments that a report on the schemes implemented in the 10(Ten) villages in border areas were sought for which to be monitored by the NIIT and Assam University, Silchar. But most of the department have not submitted the same in spite of repeated reminder. The Dist. Dev. Commissioner requested the departments to submit the same immediately.

Action: All the Heads of department
